

Accessibility Statement – Valaisin Grönlund

This accessibility statement applies to the website www.valaisingronlund.fi and was prepared on December 31, 2025. The statement is based on self-assessment and external accessibility audits. Valaisin Grönlund is committed to ensuring its website is accessible to the broadest possible audience, including people with various disabilities and users of assistive technologies.

1. Accessibility Status

The website **partially meets the accessibility requirements** set out in the WCAG 2.1 guidelines at the **AA level**. Our goal is to continuously improve the accessibility of the website to ensure equal access and usability for all users.

2. Non-accessible Content

Some parts of the website do not yet fully meet accessibility standards. These issues include:

a) Perceivable

- **Insufficient color contrast** between text and background on some elements (violating WCAG 1.4.3).
- **Missing or non-informative alt text** for some images.
- **Keyboard focus indicators** may not always be visible when navigating menus or links.

b) Operable

- **Keyboard navigation** may not be fully functional across all interactive elements.
- Some controls are **not fully accessible via keyboard**.

c) Understandable

- **Form fields** may lack descriptive labels or accessible error messages.
- **Language switching** between Finnish and English is not always marked clearly for screen readers.

d) Robust

- Some components do not fully follow **HTML standards**, which may cause issues for assistive technologies.

3. Actions to Improve Accessibility

We are actively working to improve accessibility by:

- Adding meaningful and descriptive alt texts to all images.
- Enhancing keyboard navigation across menus, forms, and product filters.
- Ensuring color contrast meets AA-level requirements.
- Validating and improving HTML structure with tools such as Axe and WAVE.
- Improving form field labels and accessible error messaging.
